



Pre-Certification Agreement

This agreement is binding between both Live Once Inc. OA Muse Pole Dance & Fitness Studio and (trainee/student name – also noted as “above named”

throughout agreement) _____ dated this ____ of _____, __14 in Mississauga, Ontario.

The above named agrees that she/he is participating in the Pole Dance or Pole Fit certification workshops with the knowledge they cannot instruct these programs or any programs derived from the attended workshops at a location within a 15 km radius from the Live Once Inc. OA Muse Pole Dance & Fitness Studio. The only circumstances where the 15 km policy may be waived is if a) it is agreed upon in writing between both the directors at Live Once Inc. OA Muse Pole Dance & Fitness Studio and the above named or b) the above named is teaching for Live Once Inc. OA Muse Pole Dance & Fitness Studio at the head location or other location designated under the Live Once Inc. OA Muse Pole Dance & Fitness Studio umbrella. This would require a separate agreement and the above named would be either considered an instructor employed by Live Once Inc. OA Muse Pole Dance & Fitness Studio or would be designated as a Live Once Inc. OA Muse Pole Dance & Fitness Studio certified instructor for a specified region.

If you have no previous pole dance experience, you must either register for the Internship program (most appropriate option) or fulfill the prerequisite requirements to participate in the Levelled certification workshops (* This does not apply to the Pole Fit Certification). To receive your 20 hours of private lessons and attend the studio classes, you must have paid a min of 75% (\$2249.25 plus GST) of the internship cost with the balance due (\$749.75 plus GST) before the end of 30 days from registration. Classes and sessions will be put on hold if payment is not received at this time. There are no exceptions for the Internship program payment.

If the above named requires continuing education to meet prerequisites for each certification level, and will be attending classes at Live Once Inc. OA Muse Pole Dance & Fitness Studio, it is with the following understanding: The above named agrees to continue with classes at Live Once Inc. OA Muse Pole Dance & Fitness Studio only with the intention of pursuing the appropriate certification which corresponds to the classes attended. This is as follows:

1A, 1B, 2A – prerequisites for the Beginner Certification.

2B, 2C, 3A – prerequisites for the Intermediate Certification.

3B, 3C, 4A – prerequisites for the Advanced Certification.

A min of 50% of the certification cost must be paid before attending the next group of classes pertaining to each level of certification. In other words, before attending 1A, the participant must pay a min of \$250 plus GST to begin the 1A, 1B and 2A classes as well as sign the agreement to pay the balance before the start of the 10 hour training session for the appropriate level of certification. One cannot continue with classes pertaining to the next level of certification until payment and commitment has been made to pursue that certification level.

The above named understands that there is no guarantee for times and dates of classes. Schedules may change for various reasons.

There are no refunds for any certification or course payments. All money is due before any workshop or course start date. The above named is committed to the full 6 weeks of any course registered for. Make up classes are only available under the following circumstances: a) at least 24 hrs notice was given b) there is space in another class of the same level in the same 6 weeks c) permission from the studio manager has been given. The above named has one year from the date of the certification course to complete the written and practical exam. If the year has passed, there is an additional charge of \$100 to write the exam.

Live Once Inc. OA Muse Pole Dance & Fitness Studio cannot guarantee that the above named will be ready to move on to each level in sequence. Each individual has a unique learning curve and if there is concern for safety or injury, Live Once Inc. OA Muse Pole Dance & Fitness Studio reserves the right to refuse entry into any class level that is deemed not appropriate for the skill level of the above named.

Live Once Inc. OA Muse Pole Dance & Fitness Studio cannot guarantee that employment will be available immediately following the certification process. Initial _

Once passed, the above named can only advertise that they are certified in the level that they have passed.

The above named cannot re-teach course: This includes sharing instructional manuals, materials, DVD's/digital downloads or any other items that are/were part of the certification program. All participants who have successfully passed the exams will be listed on our main site with the level certified in along with a bio and link to their own website.
